

If one fails to do the same, then HFI will have all rights to cancel their Provisional Membership.

- 1. Certificates of Registration under Charity Commissioner, Society, Company & Trust Act.
- 2. Bye Laws of the Society, Names & Addresses of the Office Bearers & other relevant details.
- \* The Provisional Affiliation will empower the State Hapkido Association to carry out Hapkido development activities within their region, under the guidelines of HFI mentioned below...
- To introduce Hapkido in Schools / Clubs, for both boys and girls, within the State
- To conduct at least 1 Training Camp for Coaches, under the supervision of HFI representatives in the first year of being granted provisional affiliation

To conduct at least 1 Training Camp for Players, under the supervision of HFI representatives –

in the first year of being granted provisional affiliation

• To conduct at least 1 Training Camps for Referees, under the supervision of HFI

representatives - in the first year of being granted provisional affiliation

On the basis of the 1-year performance review, the Provisional Affiliation will be extended. However, in the event that the State Hapkido Association fails to comply with the HFI guidelines, their Provisional Affiliation may be suspended and/or cancelled.
